Techniques	

- For optimum performance, 3M Temporary Surface Protection Tapes should be applied and removed at a temperature not less than 60°F (16°C).
- Surfaces should be dry and free from dirt, oil and other contaminates when tape is applied.
- Protective tape should be removed gradually beginning from one edge with a smooth even motion.

## Storage

Store under normal conditions of 60° to 80°F (16° to 27°C) and 40 to 60% R.H in the original carton.

### **Shelf Life**

To obtain best performance, use this product within 12 months from date of manufacture.
