





Fig. 7 Gate Threshold Variation vs. Ambient Temperature










Fig. 10 Typical Leakage Current vs. Drain-Source Voltage




Fig. 12 Single Pulse Maximum Power Dissipation








Fig. 13 Transient Thermal Response
